The purpose of this festival is to provide a forum for the free exchange of ideas for people on all spiritual paths, to enhance group and individual spiritual growth and well-being, and encourage local support and awareness of available products and services.

Tables and chairs will be provided. Exhibitors must provide their own signs and electrical cords as needed.

8-foot tables: \$125 for one vendor. Two exhibitors may want to share a table. The cost for each vendor sharing a table will be \$75. Each vendor must register on a separate form and submit a separate check or money order. No more than two exhibitors per table will be allowed.

Should refunds be requested, the following schedule will govern:
No refunds will be made after September 4th.

Electrical hookups are \$20. Electricity must be requested and paid for at the time of reservation. If you plug in electrical devices to another vendor's outlet or extension cord, you will be expected to pay the \$20 hookup fee.

Holiday Inn Central is located approximately ½ mile north of Interstate 80 on the East side of 72nd street.

SHOW RULES

Please list any and all items you intend to display for sale on your table application form. If it is NOT on your application, you might be asked to remove it from your table. This helps to prevent having multiple tables all selling the same items.

The booth is made available to the person who submits the application. You cannot sublease the space, even without compensation from that party, to anyone else. Please ask prior to the Mystic Fest if you have any questions about this rule, or its application.

The burning of SMALL quantities of sage is allowed prior to the doors opening to the public. Due to allergies, burning sage or incense will not be permitted once the Fest has started. Should you need to re-smudge your area, we recommend liquid, smokeless sage. Please be courteous to those vendors/readers around you.

No alcohol or drugs allowed on the premises. There is no smoking in the exhibit hall, hallways, or restrooms. Again, please show some courtesy and respect for your fellow, non-smoking vendors. Anyone caught violating these rules, will be removed from the show.

Please move your vehicles to the north or south side parking lots after unloading. Parking is somewhat limited, and should be made available for our visitors. If they cannot find a parking spot, they might just decide to go home!

You are responsible to pay any and all applicable Nebraska sales tax to the state.

Readers/vendors will NOT tear down early. The people paying admission deserve to see a complete Mystic Fest...not a fragmented one. An announcement will be made at the end of each day that the Festival is complete for that day.

Next Millennium personnel are available to watch your booth should you need to take a break. We will NOT sell anything or handle ANY money for you, but are there strictly as loss prevention.

Security will be posted in the event area overnight from Saturday closing until Sunday opening. Please ensure you take everything (purses, cell phones, medicine, etc.) with you that you will need for overnight. In order to safeguard everyone's booth and personal property, nobody will be allowed to re-enter until 10:00 a.m. Sunday.
